



# **Routine Stock Replenishment**

For further kits consisting of 25 x sample vials, 25 x brushes and 25 x sample bags, please email ghnt.hpv-supplies@nhs.net, allowing 3-5 working days for delivery. Emergency kits requested from the driver are only to be used if you have run out with usage monitored.

Sites should aim to maintain sufficient stock to cover 2-6 weeks of activity. The sample pots contain flammable liquid and therefore it is important not to carry excess stock.
