While we recognise this is a serious challenge for practices, our aim is that the day will be informative, inspirational, interactive and entertaining.

## Focus on locum cover for parental and sickness leave

As part of the GP contract negotiations for 2017/18, the BMA GPs committee (GPC) England has reached agreement with NHS Employers on changes to sickness cover reimbursement for GPs. Please be aware that <u>GPC guidance</u> has been published that reminds practices that they need to be aware that if they hold **locum insurance to cover any absence within practice t**hat the current maximum weekly payment may not fully cover the cost of a locum and the amount of time they are needed to work in the practice, particularly if they are replacing a full-time GP. For this reason the GPC and YORLMC recommends that practices review their current cover and consider maintaining a level that will allow them to top up the national payments based upon their individual and local circumstances.

## GPC guidance to assist with ongoing Capita issues

The GPC has been meeting with NHS England and Capita to highlight the ongoing issues, and some progress has been made following lobbying. However, services still fall short of what is acceptable and there is still an urgent need to resolve these issues in order to give practices and locum GPs confidence in the service. The GPC and YORLMC believe practices and individuals that have suffered losses as a result of these issues should be compensated. In recognition of the additional administrative burden on practices, a goodwill payment of £250 per practice is being made by NHS England and this should be paid to practices by 30 June 2017. This payment should not prohibit those who have suffered a demonstrable loss from being recompensed. Practices or individuals who can provide evidence of the financial loss they have incurred as a result of Capita's failures can contact NHS England to make a claim.

## Service charges - NHS property services questionnaire

GPC are aware of ongoing issues that practices in NHS Property Services and Community Health Partnerships premises are experiencing with regards to service charges. This is an issue that GPC know is of utmost importance to those practices' **occupying NHSPS or CHP owned premises** and is therefore of utmost importance to the BMA. While GPC hope to reach a negotiated agreement on these issues, GPC are considering all options to ensure this issue is addressed swiftly and the resolution is fair and reasonable for practices.

Please find attached at Appendices  $\underline{2} \& \underline{3}$  a letter and questionnaire to practices in **NHS PS premises**, and at Appendices  $\underline{4} \& \underline{5}$  a letter and questionnaire to practices in **CHP premises**. The BMA are aware of the destabilising effect the issue of service charges is causing to many practices. Through the questionnaire we are looking for information from practices on the issues, and GPC would appreciate if affected practices could fill out the attached questionnaire, and return it by 23 June 2017.

## Men ACWY April 2017 GPES collection

YORLMC understands that there was a problem with TPP and Microtech data collection linked to the April MenACWY vaccination programme and as a result there was no data returned for the practices supported by those providers.

Some work has been done and Microtech has managed to retrieve the situation but unfortunately there is insufficient time for TPP to re-run the collection and allow calculation and payment.

As this is a relatively low activity service at this time of year, NHSE have instructed NHS Digital to complete the data collection for the systems that have worked ok. For TPP NHSE will give practices 2 options.

- Practices will be offered the opportunity to complete a manual return and calculation and payment will proceed from that. This will allow them to be paid in June as expected.
- Alternatively, practices can choose to wait until the June data collection and NHS Digital will collect all activity that has been delivered in April and May. This will mean they the paid in July but does mean they do not have to undertake any additional work.

NHS Digital has issued the standard failsafe communications to put the process on hold until further advice is issued. Practices should have received further communication on this.

## **Spirometry Accreditation**

You may be aware that NHSE and the CQC have recognised the Association for Respiratory Technology and Physiology (ARTP) as an accreditation provider for clinicians that perform and/or interpret spirometry. In April 2017 the ARTP launched a National Register for certified spirometry professionals and operators. The CQC expects practices to be able to demonstrate that all staff who perform spirometry tests or interpret results are competent, and advise that being on the National Register demonstrates competency. There are significant time and cost implications for clinicians to become registered with the ARTP.

YORLMC understands that many practices feel that providing spirometry services will become financially unviable should they be required to meet these additional training and registration costs. We would like to remind practices that they are not under any contractual obligation to provide spirometry services. Practitioners are not required to register with the ARTP until 2021 and so in the meantime YORLMC would encourage practices not to rush into registering their spirometry clinicians, but to wait and see whether any assistance to support the accreditation costs is forthcoming.
