Important information relating to GPR reimbursements

To ensure that any registrar appointed to a vocational training scheme receives the correct salary and is placed on the correct pay scale a new process was introduced by PCSE that requires completion of a new K4 form.

Following enquiries made on behalf of constituent practices, YORLMC subsequently established the following:

not all practices are aware of the new form

• some practices may be of the understanding they have already provided PCSE with the information required but if this has not been submitted on the form attached it will not be processed

 there is also the possibility that a number of K4s have been returned from PCSE to HEE that have not been actioned

• there may also be some practices that have returned new form K4 but there is information missing from the form

Extending the flu vaccination programme

NHS England, <u>Public Health England</u>, the <u>Department of Health</u> and <u>NHS Improvement</u> have published their plans to boost the uptake of flu vaccinations. Amongst those plans is the expansion of the GP and national pharmacy service so that care home workers are able to access the flu vaccine via local GPs and pharmacies free of charge. The GPC is now in the process of working with NHS Employers and NHS England to agree the funding and practical arrangements for this. Announcement of state backed indemnity scheme in England

On 12 October 2017 the Secretary of State for Health announced that the Department of Health is planning the development of a state-backed indemnity scheme for general practice in England, subject to further work on relevant issues. The Department understands that the rising cost of clinical negligence is a great source of concern for GPs and impacts negatively on the GP workforce, and is seeking to put in place a more stable and more affordable system of indemnity for general practice. This announcement comes after sustained lobbying and engagement by GPC over many months.

The DH position on the wider aspects of the scheme are set out in an <u>indemnity factsheet</u> (produced in conjunction with GPC) which contains the current assumptions on key areas, including scope and expected timelines. BMA commentary on the announcement is available on the BMA website - <u>Call for more details on indemnity scheme</u>. The DH is to set up a stakeholder group, and arrange a first roundtable next month with GPC and RCGP representatives. Although many tough discussions and negotiations will lie ahead, the announcement of a state-backed scheme is an important step towards the help that GPs have been calling for.

Following the DH announcement, MDU advised that its membership benefits for GPs working under an NHS England contract who renew/join after 1st Nov will change to '<u>Transitional Benefits</u>' intended to provide the indemnity until a state-backed scheme is introduced. Yesterday the Department of Health directly addressed this offer by <u>amending its indemnity factsheet</u>

This complex piece of work is at an early stage and this announcement marks the start of detailed work that will involve the GPC to develop DH plans. The intention is to seek to establish any new scheme as quickly as possible, however it is likely to take 12-18 months to develop.

In the meantime and with the above information in mind, we would like to remind GPs of the requirement to maintain full indemnity cover before any change to a state-backed scheme in the future.

Guidance for patients about referrals

NHS England has produced a <u>leaflet</u> for patients which explains to them what they can expect to happen if they are referred by their GP to see a specialist or consultant at a hospital or a community health centre. The GPC has worked very closely with NHS England and the National Association for Patient Participation to produce this leaflet and practices are encouraged to use it.

Annual Electronic Declaration (eDEC) 2017/18

Practices are reminded that the 2017/18 eDEC opened for submissions from Monday 16th of October to Wednesday 29 November 2017. All GP practices are required to submit their eDEC electronically through the primary care website: <u>www.primarycare.nhs.uk</u> as per the Policy and Guidance of Assurance Management Framework of Primary Medical Services. YORLMC understands that NHSE Y&H has written separately to practices to highlight this requirement.

Prevent and the Annual electronic declaration

YORLMC is aware that one of the eDEC return asks practices to confirm that healthcare workers employed by the practice are familiar with the Government's Prevent strategy and that all GPs (partners and salaried) have attended PREVENT training in the past 3 years. GPC has confirmed that PREVENT training is not mandatory and therefore there will be no repercussions for practices responding 'no' to this question – it is a simple information gathering question rather than assessment against requirements. The question itself is voluntary and also should not be in the indemnity section. GPC are working with NHS England to ensure supporting advice for the e-dec reflects the above, but GPC have been advised that the question itself cannot be changed once the eDEC is live.
