The completion of the Spring round of North Yorkshire & York YORLMC roadshows on reflection has been a valuable opportunity to meet both GP colleagues and Practice Managers and to inform and gain feedback on current practice priorities. A clear shift is evident that practices want to work more collaboratively whilst preserving the personal care they deliver locally in their practices. The 2018/19 NHS England/NHS Improvement <u>guidance</u> has stated the requirement on CCGs to develop locally primary care networks of 30-50,000

patients across their areas. YORLMC is starting to work with CCGs to develop this in more detail and ensure a bottom up approach with GP ownership.

Nationally the decision of the Health and Social Care Secretary to commission an <u>independent review of the GP Partnership</u> model is welcomed by YORLMC with the recently announced good news by GPC that this will be led by Dr Nigel Watson a well respected LMC colleague from Wessex.

As we move further into the 2018/19 financial year the full outcomes of the capacity and capability reviews and implications for CCG configurations moving forward are still awaited.

Extended Access

Please see the below statement from Dr Brian McGregor, Medical Director, YORLMC:

Practices will be aware that CCGs are required to provide extended access to GP services, including at evenings and weekends, for 100% of their population by 1 October 2018, and including access at bank holidays and across the Easter, Christmas and New Year periods. YORLMC has considered this and whilst there was the opportunity to raise awareness of the potential benefit/ cost for practices at the recent roadshows that took place across the 4 North Yorkshire localities for those GPs/practices who were unable to attend these events I would like to reiterate YORLMC's view.

The contract changes this year will bring £256.3 million into General Practice for a multiple number of small changes; however, the extended access funding of £6 a head will bring over £300 million of funding for a single project. It is YORLMC's view that this is the ONLY new funding coming into Primary Care for new work this year, and it is preferable for this funding to stay within General Practice and not be fed into alternative providers. CCGs have this as a "must-do" in their guidance so it will happen.

8-8 working 7 days a week does NOT mean individual GPs being available for all that time and does NOT mean you need to provide this within your own practice. Working smartly and efficiently, it means General Practice in its entirety is available over 7 days; most CCGs are asking for 30 minutes per 1000 patients, over and above current provision. This means all professions working within practices can be utilised – HCAs, treatment room and chronic disease management nurses, counsellors, phlebotomists, pharmacists, dieticians, and when GPs are used, their consultations can potentially be digital (e.g. skype, email) and not necessarily based in a surgery.

Consequently, it is YORLMC's view that this provision can be managed in a cost effective way with minimal impact on already overloaded GPs and could even be provided in partnership with other providers who could service some of the clinical provision.

YORLMC strongly encourages all practices to engage and look at breaking down any barriers to implementing this service as quickly as possible. CCGs are currently looking at practices as pre-ferred providers but need to have a service in place by 1st October 2018.


